Record Status This competition will be liable for Drug testing and competitors approached to give samples must comply. If they refuse, that refusal will be treated as a positive result. Juniors must have written parental consent. (This is given by a parent signing the entry form)

Arrows The venue is a public field so we would prefer that no "all carbon" arrows are used. If you do intend to shoot "all carbon" arrows then please state on the entry form how you will detect them.

Competitors You must conform to correct AGB dress regulations (307). Only members of Archery GB or World Archery are permitted to shoot at the tournament.

Warning Neither the Bowmen of Lytchett nor the owner of the venue will accept liability for loss, damage or injury whilst on the premises. No dogs are allowed on the shooting field. No crossbows.

Photography Anyone who wishes to take photographs or videos of the event must register with the tournament organiser first.

Refreshments There is a sports bar located at the venue where you can purchase food and drinks. It is advised that you pre-order your food in at the start of the tournament to ensure it is ready at the start of lunch.
